Q&A w/ Distinguished Guests

- Representative Ligon- Chester is booming with economic development- E&J Gallo, Albemarle (have plans for recycling lithium in phase 2)
- Senator Johnson- Was at York County MRF the day it was dedicated. Where is the demand for recycled products? He does not have access to recycling curbside.
- Representative O'Neal- Former Mayor of Tega Cay says they stopped recycling plastic because of York County MRF stopped taking material. Economics of recycling are dynamic.
- Steven Willaims and Alysen Woodruff address the misconception that York County MRF stopped accepting plastic. This never happened. They do not accept glass because it is a contaminate and the MRF cannot handle it. They deal with a lot of misinformation and this is a big challenge for them.
- Council members discuss challenges in the industry.

- Consistent recycling messaging in our state is a priority for the council. This can be done by bringing private industry and counties coming together.
- Glenn Odom says biggest mistake our state made in residential recycling was going single stream. Clean stream brings the most value.
- Kevin Richardson says separating at the source during collection is very laborious and intense for workers. Cost has also increased across the board in the last several years for new equipment.
- Europeans separate their recycling because they don't have space for landfills, whereas in the West we have.
- Brad Dutton suggests we put plastic or rubberized in our roads. The material lasts longer than traditional asphalt. Requiring the lowest bid for state procurement may shortchange this opportunity.
- Carol Gilchrist discusses Project Horizon and Sonoco's need to capture more cardboard, and their commitment to sustainability. Project Horizon was initiated, in part, to ensure the long-term viability and sustainability of Sonoco's 100-year-old Hartsville Mill Complex, at which the Company produces almost one-third of its U.S. and Canadian URB. The introduction of the new operation is projected to drive \$30 million in annual cost savings by 2024 and will ensure the mill remains globally competitive.
- This launch also marks Sonoco's move to 100% recycled fibers in the Hartsville Mill Complex, which eliminated the manufacturing complex's virgin pulp processing and chemical recovery operation. This conversion to 100% recycled fiber is expected to reduce electricity consumption, driving reductions in greenhouse gas emissions and total water use—advancing Sonoco's long-term sustainability commitment.
- Odom- All the carpet going to Wellman Plastics is coming from out of state.
- Williams says at times the price of virgin plastic is out competing recycled plastic which makes it difficult for the MRF
- Adam Padgett discusses Green Energy Biofuels issues with oil thieves which are costing them 10% of their revenue. Hired a lobbyist to make it a felony rather than a misdemeanor. Blythewood High School has an 8-week biodiesel program that will cost 50k-school needs funding.

Michelle LaRocco will be leaving the council and Georgetown County to work for Cirba Solutions. She says farewell to the council.

Market Updates submitted electronically

Metal: Aluminum LME 2325 UBC's .73 cents/.lb del mill.

MSW: Volumes have declined somewhat at the landfills however MRF volumes are up. The zero to landfill expense has risen significantly and in some cases companies are revisiting waste to energy opportunities.

October pricing will come out on the 5th and we anticipate a \$5 - \$10 per ton increase in OCC, due to increased export movement to store up for their holiday season and typical US 4th quarter holiday generation.

Plastic: PET market prices are pushing higher due to oil price. With higher virgin price, recycling will get better. Market is still slow with certain markets slow Automotive and Furniture. PET recycling will be hindered with the Auto strike thus stopping production if it last more than a month. There is a large push to increase the amount of recycle PET used in textiles and the focus is turning to the Brands to make this happen. Today 14% recycle is used by clothing brands. With the push to increase recycle content will put added pressure on good quality PET bottle flake.

Carpet: Nylon 6 and Nylon 66 price are both down in price. PP Price is down. Still no market for PET Produced from Post Consumer Carpet

Glass: Clear clean cullet is 60.00 per ton. Green clean cullet is 30.00 per ton. Brown clean cullet is 15.00 per ton. Mixed clean Tri color is 10.00 per ton. Single stream glass is cost of trucking & disposal.

Petroleum: Retail gas prices have dropped slightly over the last month. Average price per gallon in the US as of 10/2/23 was \$4.05 per gallon. US Diesel prices had a slight uptick with an average of \$4.59 per gallon. Crude oil has also had its steepest drop since March of 2023 with WTI Crude oil valued at \$88.81 per barrel as of 10/2/23.
